Terms and Conditions

1. The Pass - only one guest pass per individual over the age of 18 - entitles you to enjoy access to Basingstoke Sports Centre, Festival Place, Basingstoke RG21 7LE or bstfitness Newbury Park Way, Newbury, RG14 1EE.
2. All 3 day Passes must be registered on <https://basingstokesc.legendonlineservices.co.uk/basingstoke/OnlineSignup/SingleSignup> if using Basingstoke Sports Centre or <https://basingstokesc.legendonlineservices.co.uk/newbury/OnlineSignup/SingleSignup> if using bstfitness Newbury
3. Once registered all passes must be presented at Reception on each visit and is activated on the date of the first visit. Passes are valid for, one class, gym sessions or lane swim per visit only. Any other activities booked will incur a charge at the current rate.
