



TERMS AND CONDITIONS – CORPORATE MEMBERSHIP

These Corporate Membership Terms and Conditions are in addition to Basingstoke Sports Trusts current T&C - (Link as displayed on the Basingstoke Sports Centre's website. www.mybst.org)

1. In order for an organisation/company or group of companies to benefit from a BSC corporate membership, they must have a minimum of 10 employees on the scheme. Failure to maintain a minimum of 10 employees on their scheme may result in the membership being transferred to a full price, Premier or Just Gym membership. Notification of any impending transfer will be advised 30 days prior to any transfer taking place.
2. Corporate Membership are:
 - a. Premier @ £34.95 per month
 - b. Just Gym @ £24.95 per month
 - c. Premier @£384.45 Paid up front
 - d. Just Gym @£274.45 Paid up front
 - Corporate Membership is subject to a £15.00 joining fee except:
 - a. Those who work for BDBC, HCC, Festival Place Staff and NHS – Zero Joining Fee
 - b. Those Festival Place retailer employees who have a star card – 50% off the joining fee
 - c. Those Retailers in the Basingstoke Business Improvement District (BID) Scheme - 50% of the joining fee with the presentation of a BBID card
3. Corporate monthly membership fees are payable by Direct Debit on the 1st of each month.
4. All initial corporate memberships are for a period of 12 months. After the initial contract period, this membership reverts to rolling monthly membership. Should you wish to end your membership after the initial contract period, see **clause 10 of the main T&C of membership on how to end your membership**
5. Memberships are not transferable between staff/employees
6. Premier memberships can be upgraded to include rackets sports at the current upgrade fee.
7. Just Gym members will need to pay and play for extras such as Swimming, Exercise Classes and racquet sports.
8. Corporate Memberships have a price for life so long as the membership is continuous



9. All Corporate members need to:
 - a. Complete a membership form and medical questionnaire
 - b. supply a copy of a recent payslip (not more than 2 months old) or letter from your employer, confirming your employment status
 - c. Book and complete a gym assessment or complete a gym waiver form
 - d. Make an initial payment (joining fee/subscription)

10. If an existing member on a 12 month contract wishes to move to their Companies Corporate Membership – they can upgrade/downgrade by cancelling their existing membership and commence a new/initial Corporate membership. In these cases a £25 Administration fee will be charged

11. Corporate memberships are for age 16 and over; you may be asked to provide proof of your age. If under 18, parental authorisation will be required and a Gym Induction must be completed and counter signed by a Parent

12. No two offers/promotions can be combined (ie – Star/BBID Card together with Refer a Friend offer)

13. If upgrading/down grading – the member must complete an amendment form and if required, pay the required transfer fee
