2. CTDGP will only be valid if issued with an expiry date 7 days from the point of issue and initials of the issuing duty manager or senior staff. All three visits must be redeemed by the expiry date.
3. Guests to bstfitness Newbury must present the pass at Reception to be exchanged for a stamp card. Passes are valid for classes, gym sessions, swim and sauna, if available.
4. Stamp cards will be issued with a Quick Add membership number, and will have a photo of the guest attached to their account to verify identity.
5. Only one pass per person per calendar month. After CTDGP pass all day passes will be charged at the standard guest fee rate.
6. bstfitness Newbury reserves the right to refuse entry to any person if it suspects abuse of this offer or otherwise in its reasonable discretion.
7. Use CTDGP guest pass is subject to satisfactory completion of a Health Commitment Statement and acceptance of the Club Rules available our website (www.mybst.org/terms).
